

## Tokio Marine Asset Management Japanese Equity Shareholder Voting Results

### Number of proposals approved and opposed

The table below shows the results of shareholder voting rights exercised by Tokio Marine Asset Management Co., Ltd. Tokyo (TMAM) at shareholder meetings from April to June 2020. We voted on a total of 10,506 individual proposals, approving 9,331 and opposing 1,175 (11.2% opposed). Of 4,221 proposals subject to increased scrutiny, we voted to approve 3,112 and oppose 1,109 (26.3% opposed).

### Overview of shareholder voting results

Key issues in shareholder voting from April to June 2020:

- We continue to vote in accordance with TMAM guidelines. We have also been investigating how individual companies are responding to the Covid-19 pandemic.
- Our Responsible Investment Committee refers to recommendations provided by a proxy advisory firm in order to avoid any conflict of interest.
- Where necessary, we publish the rationale behind decisions in our table of full shareholder voting results.

**Shareholder voting and Covid-19**

Our approach to stewardship during the Covid-19 pandemic remains unchanged: we aim to contribute to the sustainable growth of the companies in which we invest. As part of this, we have been investigating how individual companies are responding to Covid-19, and reflecting this in how we vote.

Many companies saw earnings for the fiscal year ending March 2020 take a huge hit from the pandemic in the January–March quarter; accordingly, we have taken into account a range of factors including earnings up to the October–December 2019 quarter, management policy and response to the crisis, and balance sheet health. These considerations allowed us to exercise our shareholder voting rights based on a holistic understanding of the situation in which individual companies find themselves, rather than a purely mechanical application of our voting guidelines.

**Managing conflicts of interest**

Where the exercise of voting rights may have an impact on our management due to capital ties, business relationships or other such reasons, we take advice from a proxy advisory firm and vote in accordance with the Responsible Investment Committee’s decisions in order to avoid any conflict of interest.

Where there is a potential conflict of interests, the Responsible Investment Committee considers the recommendation of a proxy advisory firm as its base case. Where such a recommendation is less rational than our own voting guidelines, however, or in certain cases where shareholder proposals need to be considered on their own merits, we may vote against such recommendations.

Proposals for investee companies where there is a potential conflict of interests are flagged as such in the full table of shareholder voting results, with rationale provided for exceptional decisions.

We will continue to use shareholder voting as a tool to request that the companies in which we invest address corporate governance in good faith and for the interest of beneficiaries.
