## 2. Overview of shareholder voting results

TMAM voted on a total of 1,724 proposals at shareholder meetings from January to March 2019, approving 1,590 and opposing 134 (7.8% opposed). Of 668 proposals subject to increased scrutiny, we voted to approve 536 and oppose 132 (19.8% opposed). Details of how we voted on each proposal can be found below.

We will continue to use shareholder voting as a tool to request that invested companies address corporate governance in good faith and for the interest of beneficiaries.
