We also publish our rationale for proposals subject to potential conflict of interest review, where unlawful or unethical behaviour has been detected, where our decision ran against TMAM guidelines, and for other case-specific factors.

We will continue to use shareholder voting as a tool to request that the companies in which we invest address corporate governance in good faith and for the interest of beneficiaries.
