

Tokio Marine Asset Management Japanese Equity Shareholder Voting Results

Number of proposals approved and opposed

The table below shows the results of shareholder voting rights exercised by Tokio Marine Asset Management Co., Ltd. Tokyo (TMAM) at shareholder meetings from July to September 2023. We voted on 520 company proposals, approving 431 and opposing 89 (17.1% opposed). We opposed 18 of 19 shareholder proposals (94.7% opposed).

Key issues in shareholder voting from July to September 2023:

- We voted in accordance with TMAM basic policy and guidelines on shareholder voting.
- This quarter there were no proposals with potential for conflicts of interest.

Overview of voting on company proposals and shareholder proposals

Company proposals

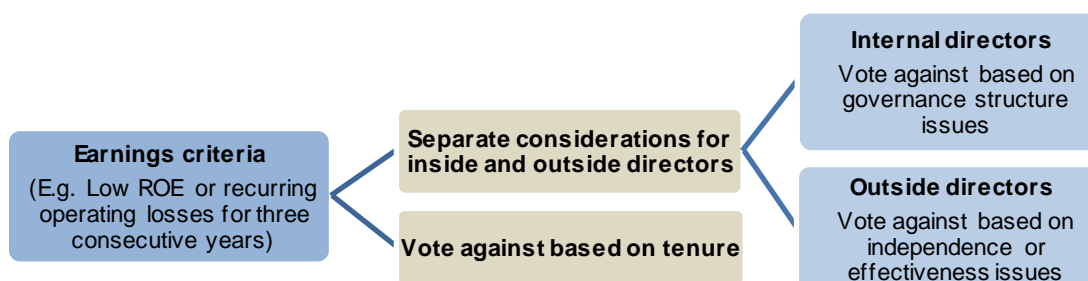
- Vote against the appointment of outside directors where the candidate has been in post for over 10 years, is an employee of a business partner or major shareholder, or otherwise fails to meet TMAM's independence guidelines.
- Vote against the appointment of directors where board transparency may be impaired, including where the number of independent outside directors fails to meet TMAM guidelines.

Reasons for voting against appointment/dismissal of directors

- Screening based on whether a company has met earnings criteria
- Where a company meets earnings criteria, discussions are held on a case-by-case basis; as a general rule we vote against appointment where earnings fall short of our screening criteria.

Shareholder proposals

- Vote in favour of share buybacks depending on nature of proposal and financial conditions.



Disclosure of shareholder voting results

In addition to our decision on each individual proposal, we disclose our rationale when voting against company proposals or in favour of shareholder proposals. We also publish our rationale for proposals subject to potential conflict of interest review, where unlawful or unethical behaviour has been detected, where our decision ran against TMAM guidelines, and for other case-specific factors.

We will continue to use shareholder voting as a tool to request that the companies in which we invest address corporate governance in good faith and for the interest of beneficiaries.
