### 2. Overview of shareholder voting results

TMAM voted on a total of 521 proposals at shareholder meetings from October to December 2019, approving 461 and opposing 60 (11.5% opposed). Of 256 proposals subject to increased scrutiny, we voted to approve 197 and oppose 59 (23.0% opposed). Details of how we voted on each proposal can be found below.

We will continue to use shareholder voting as a tool to request that invested companies address corporate governance in good faith and for the interest of beneficiaries.
